UCL have to look after the information you give us, and this means they are called the 'controller' of the information collected about you.

Information about you that we collect

Your name and contact details

Some of things we will ask you about in the research are sensitive. This is special information about who you are, such as your health, the colour of your skin, your beliefs about God or religion.

Who will see your data?

We follow the rules of **Data Protection Law**.

We will keep the **information** about you and your data **safe, protected and locked**. We sometimes call the information we collect 'data'.

Only the researchers will see this **data**.

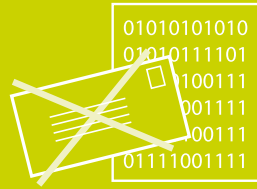
At the end of the research, we will share our research results with you.

Afterwards, we will **take out** your **name** and **personal details** from your data (address, email address, telephone number).

No one outside the research team will know **who you are** from the data.

We may **share** your information and data with **other researchers** in this **country**.

We may **share** your information and data with **researchers** in **other countries**.

We will take out your name and personal details.

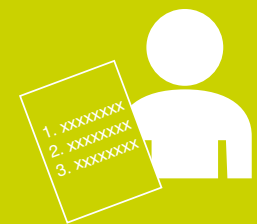
No one outside the research team will know who you are from the data.

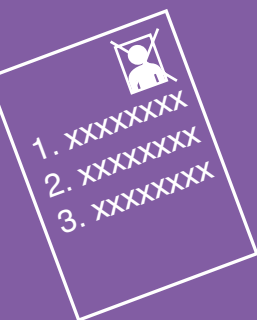
How we use your information and what will happen after the research?



We will **give you the results** of the research.

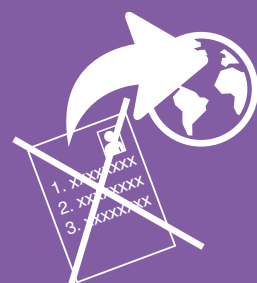

We will not transfer any information that identifies you to other countries

LAW



We can only use your data if we have a legal reason to do so and for this study the research is done because it's interesting and important to the general public. The law allows universities to do this sort of research. The proper name for it is a 'task in the public interest'.
